This Memorandum of Understanding (MoU) was made and entered into this on 19/12/2023 between the Wadihuda Institute of Research and Advanced Studies (WIRAS), Vilayancode, Kannur, Kerala as **First Party** and SAFI Institute of Advanced Study (SIAS) Vazhayur, Kerala as the **Second Party**.

Wadihuda Institute of Research and Advanced Studies (WIRAS) is affiliated to Kannur University and recognized by the Govt. of Kerala. It is a premier institute of the Ta'aleemul Islam Trust, a non-profit trust with the aim of providing quality education to the students of all sections of the society. During the lecture(s) or interactions, the faculty member may be considered to be on duty at the beneficiary institution. Heads of the Institution may mutually alter the dates if such duties of assigned faculty members are seen to hamper important academic or evaluation assignments at his / her place of posting.

Joint Submission of Collaborative Projects: Faculty members of WIRAS and SIAS may submit joint project proposals for funding from different funding agencies.

Joint organization of Seminars / Symposia / Workshop: Seminars / Workshop / Symposia may be jointly organized by faculty members of both WIRAS and SIAS

Joint fieldwork: Both Colleges may jointly organize field works that are part of the curriculum. This way both the institutions may utilize the expertise of individual faculty members for the benefit of the students.

Guidance in Career counseling: WIRAS and SIAS will share information on career counseling and opportunities for higher students in India and abroad.

Joint organization of Placement drive: WIRAS and SIAS will jointly organize Placement drives for the benefit of the outgoing and passed-out students.

This is a non-binding MoU and there shall be no financial obligation on the part of WIRAS and SIAS.

Both WIRAS and SIAS agree that any information which is exchanged under this Memorandum of Understanding will be kept strictly confidential and used solely for the purpose, covered by this Memorandum of Understanding, unless such information was obtained by a third party who does not have an obligation of confidentiality toward the information-disclosing party and entered public domain.

Subject to the clause below, both the Institutions may amend this Memorandum of Understanding by mutual consent in writing. Any amendment agreed by the Institutions shall come into effect from the date determined by the signing College / University.

This Memorandum of Understanding shall enter into force on the date of signing and shall initially be valid for a period of three years. There both WIRAS and SIAS shall agree on mutual consent on the continued validity of this Memorandum of Understanding.

In any other circumstance or other detailed collaboration between the two parties, a separate MoU shall be drawn up as and when required.

The institutions, WIRAS and SIAS agree that this Memorandum of Understanding shall enter into force based on goodwill and shall not be legally bound. Nothing mentioned in this Memorandum of Understanding shall be deemed to constitute a partnership between the signing Institutions appointing one party as an agent of the other.

This Memorandum of Understanding will be effective upon signature by both the Head of Institutions for a period of three years, at which time it will be reviewed for possible renewal for a further three-year period. Either party may, on three (03) month notice in writing, terminate the MoU in advance of its normal expiration or request the recognition of its conditions.
